We are a privately owned club where the stockholding members own the course and property. The initial membership contract is for a period of 12 months. After the 12 months your membership becomes month to month for as long as you wish. This does not include any cart usage. Since the members own the course we have several cart options. We allow you to own your own cart and store the cart on the premises in one of our cart sheds, pay a monthly fee to use one of the club owned carts, or rent a cart on a per time bases. The following information provides all the rates and options available to you. The rates provided include all sales taxes.

You will find two parts to your membership application. The first part outlines contract conditions and policies which go to the board for approval. The second part is where you choose what membership option you qualify for. You may start your membership at any time you wish on a provisional basis until the board makes it official.

All memberships will be either an automatic draw (ACH) from a bank account or automatically charged to a credit card. At any time before payment is due you always have the option to pre pay if you don't wish to have the automatic draw, or credit card draft from your account.

Your membership includes all immediate family members including children who are dependents and a full time student up to the age of 25. Your membership includes Golf and Clubhouse privileges.
