Thank You for your interest in Woodland Hills Membership:

We are a privately owned club where the stockholding members own the course and property. The initial membership contract is for a period of 12 months. After the 12 months your membership becomes month to month for as long as you wish. This does not include any cart usage. Since the members own the course we have several cart options. We allow you to own your own cart and store the cart on the premises in one of our cart sheds, pay a monthly fee to use one of the club owned carts, or rent a cart on a per time bases. The following information provides all the rates and options available to you. The rates provided include all sales taxes.

You will find two parts to your membership application. The first part outlines contract conditions and policies which go to the board for approval. The second part is where you choose what membership option you qualify for. You may start your membership at any time you wish on a provisional basis until the board makes it official.

All memberships will be either an automatic draw (ACH) from a bank account or automatically charged to a credit card. At any time before payment is due you always have the option to pre pay if you don't wish to have the automatic draw, or credit card draft from your account.

Your membership includes all immediate family members including children who are dependents and a full time student up to the age of 25. Your membership includes Golf and Clubhouse privileges.

Policies and Conditions

- If unlimited cart is chosen: **It is required that you double up with other golfers in a club cart whenever possible.** No more than one of the club's cart is to have a single rider per group. Club carts per family are based on "One Cart Moving per membership". If a spouse or child in the membership has to take a second cart, regular cart rental fees are to be paid.
- You may have joint ownership of a private cart, however all parties under separate memberships must pay a trail fee. Only one shed rental will apply.
- In some cases the stockholders may vote for one time assessments and or a dues increase for funding projects or for business operational needs.
- No selection of a cart option means that carts will be rented on a per play basis.

At the conclusion of the 12 month total contract period the membership will be considered month to month. ***Termination of membership after the initial contract must be submitted in writing a full 30 days before termination is considered effective.*** In the event of termination after the initial contract, the applicant may not apply for reinstatement for a period of one year from termination membership, unless a) the amount for the period of membership lapse is brought current, or b) special board approved medical leave is granted and assessments are paid during this period of leave. (2) If the member drops out the club before the 12 month commitment, the remainder of the 12 months will be due immediately in one lump sum payment. (3) If the club institutes legal proceedings to collect any unpaid balance, member agrees that the club shall be entitled to recover all court cost incurred in obtaining any judgment and reimbursement for reasonable and necessary legal fees incurred by the club in obtaining said judgment. (4) The board of directors can terminate this contract for violation of the terms of this membership.
